Establishment of Programs

PARENT AND COMMUNITY PARTICIPATION

Bilingual Parent Advisory Council **BPAC**

WHO?

Each district or cooperative shall establish a parent

advisory committee consisting of:

□parents, legal guardians,

transitional bilingual education teachers,

□counselors, and

□ community leaders.

The majority of committee members shall be parents or legal guardians of students enrolled in these programs. Membership on this committee shall be representative of the languages served in programs to the extent possible. (Section 14C-10 of the School Code [105 ILCS 5/14C-10])

PARENT AND COMMUNITY PARTICIPATION

WHAT? This committee shall participate in the planning, operation, and evaluation of programs.



The committee shall:

Imeet at least four times per year;

Imaintain on file with the school district, minutes of these meetings; and

☐ review the district's annual program application to the State Superintendent of Education

Each district or cooperative shall ensure that training is provided annually to the members of it parent advisory committee.....



2001 – No Child Left Behind (NCLB) Act, Title III

The purpose of the Title III Part A is to help ensure that children and youth who are limited English proficient, Native American and/or immigrants,

- □attain English language proficiency,
- develop high levels of academic attainment in
- English, and
- meet the same challenging State academic standards that all children are expected to meet.



Therefore, school districts are prohibited from requiring:

- ☐U.S. passports,
- □ social security numbers,
- ☐ residency permits known as "green cards," or
- ☐ any documentation or inquiry that would indicate whether a child or family was or was not a legal

resident or citizen of the United States.



Transitional Bilingual Education

Illinois School Code
Section 228.25 Program Options, Placement, and Assessment

"When an attendance center has 20 or more LEP students of the same language classification, the school must establish a TBE".

The Transitional Bilingual Education (TBE) program is for non-native English speaking students who come from a high incidence language background. The program provides instruction in the student's native language with transition into English.

Transitional Program of Instruction

Illinois School Code
Section 228.25 Program Options, Placement, and Assessment

"When an attendance center has 19 or fewer LEP students from any single non-English language...

This program is for non-native English speaking students who come from a low incidence language background. The program provides instruction in the English language using *Sheltered English Instruction (ESL)*.
